# INTRODUCTION

ISF World Schools Championships (WSC) are events characterised by a balanced programme between sport and educational content: the balance between sport and education is to create awareness about the role of sport in putting forward topics such as fair play, healthy lifestyle, respect, inclusion. WSCs are open to the participation of school teams only. Beside the name of the respective member, teams will defend the colours and name of the specific school they represent. This format is meant to create a strong identification between the students and the school they attend. WSCs are team competitions, meaning that individual events do not award any medals, but only contribute to the final team result. The number of teams per delegation per category differs from sport to sport.

One ISF member may enter the WSC with more than one school team.

Age categories for WSC are outlined in the respective sport-specific rules.

The educational programme and the sport format of the event shall always be adapted to the age of participants: in general, in events for lower age categories, the educational content will have a more prominent role.

# 2. Travelling & Visa

Travel as far as International Airport Nikola Tesla – Belgrade and Belgrad railway station is to be arranged and financed by each participating country. When the distance between the host city and the capital of a participating country on another continent exceeds 5000km, the delegation may extend its stay by arriving one day earlier or leaving one day later at the standard daily fee.

Delegations are to arrive on 27.6.2020and depart on 05.07.2020 after breakfast.

The organisation of an extended stay for the delegation (before or after the event) is a matter for the country concerned. It shall not be the responsibility of the Local Organising Committee (LOC).

#### **TECHNICAL DETAILS**

## 1. Participation

The WSC Handball is open to school teams only.

All participants in a school team must be enrolled at the same school since the beginning of the school year in which the event takes place.

# All students must be attending schools which provide a general education. The following are not eligible to participate:

- Pupils of vocational schools who only attend that school as a complement to their vocational training.
- School teams and pupils enrolled at schools which provide sports training without any general education.
- Part-time sport schools which take pupils from a variety of schools for training in one or more sports.
- Teams formed as part of clubs, companies, universities or other institutions.

#### Participants obligations:

- Each participant is required to be present throughout the whole duration of the event.
- Each participant is obliged to take part in all the non-sport activities.
- Each team undertakes to compete against all other participating teams.
- Each participant undertakes to compete against all other participants.
- The absence of any member of a participating team from any part of the entire sport, opening, prize-giving and closing ceremonies and socio-cultural programme may result in the team being excluded from the final results.

#### The championship will be held in 2 different categories:

- School Girls
- School Boys

Each country may enter up to 2 teams per category (see REGISTRATION).

#### Head of Delegation (HoD)

He/she may not combine the function with the role of coach or another official role. He/she shall be the sole intermediary between the delegation and the Local Organising Committee, the ISF Technical Commission and the ISF Delegate.

#### Coach

There is a mandatory amount of 2 coach per team.

#### Additional adults

The function of each additional adult must be specified during the registration process (doctor, physiotherapist, interpreter, security personnel, ministry representative, media, etc...). Delegations can register up to 4 additional adults if they participate with up to 2 teams; 8 additional adults can be registered with more than 2 teams participating. Any other additional person not specified during registration or exceeding the quotas specified in this document will not be considered parto of the official delegation and will not be accredited by the LOC.

#### Referees

Each delegation participating in the championship with 1 or 2 teams shall appoint one pair of referees. Each delegation participating in the championship with 3 or 4 teams shall appoint two pair of referees. It is advisable to nominate referees in cooperation with the respective National Handball Federation. All costs shall be covered by the delegation. Failing to appoint referees will result in a fine of 1800 Euros per pair, to be paid together with the final balance. All referees shall preferably be under 28 years of age and in possession of the highest national level (from the respective National Handball Federation) or beginning international level. All referees over 28 years of age shall be international level.

#### 3. Technical Rules

The WSC Handball will be held under IHF regulations and ISF Handball rules (<a href="https://www.isfsports.org/sites/default/files/technicalrules\_hb\_0.pdf">https://www.isfsports.org/sites/default/files/technicalrules\_hb\_0.pdf</a>), under the supervision of the ISF Technical Commission for Handball.

# 4. Anti-doping

Dope testing for use of banned substances can take place during the competition according to current ISF Anti-Doping Rules (<a href="http://isfsports.org/sites/default/files/isf-anti-doping-rules\_0.pdf">http://isfsports.org/sites/default/files/isf-anti-doping-rules\_0.pdf</a>).

If selected for testing, a competitor, if minor, must be accompanied by an adult. If a competitor is following a course of medical treatment which includes the use of prohibited substances according to the current WADA prohibited list, he/she must obtain a TUE (Therapeutic Use Exemption) from his/her National Anti Doping Agency (NADO).

#### **Administration**

# 1. Registration

Registration will only be possible through ERAS the ISF online registration platform (<a href="https://isf-eras.org/">https://isf-eras.org/</a>). No other registration system shall be accepted.

Registration phase 1 for the ISF WSC Volleyball 2020 shall be from October 7, 2019 to November 30, 2019. During registration phase 1 all countries will be requested to indicate the number of teams per category that they wish to enter. All first teams in each category will be accepted; a decision concerning the second teams shall be made by the ISF by December 31, 2019, depending on the total participation quota indicated by the LOC.

All countries are expected to pay the deposits for their first teams or to reach an LOC agreement (see chapter below) by December 31, 2019. Registration phase 2 will only be open after the deposit has been paid or an LOC agreement has been reached by the delegation concerned.

The ISF shall inform all registered country about the possibility to go through with the entry of a second team. All deposits for the second/third teams are to be paid by January 31, 2020.

Registration phase 2 shall be open from January 1, 2020 to February 10, 2020: during registration phase 2 all countries are expected to enter the exact number of the delegation members.

#### Registration deadlines

#### 2. Fees

#### a. Participation

In accordance with the rules laid down by ISF, the payment to be made to the organisers of the event will follow the rates indicated in the table below. All rates are per night.

The participation fee covers full board accommodation for the duration of the event plus competition, cultural programme activities and all local transport from the arrival to the official port of entry to the departure of the team.

#### b. ISF Levy

An additional ISF levy of 40€ per delegation member must be paid together with the balance of the participation fee

#### c. Gala Dinner

A charity gala dinner is organised during the event. All Heads of Delegation are expected to take part in the dinner; in addition, all adults in the delegation can attend, upon registration through the ERAS system. The gala dinner fee is 50€/person, to be paid together with the final balance. More information concerning details of the gala dinner will be provided in Bulletin 2.

#### d. Final Balance

The table below shows an overview of the minimum total event fee per participant

The final balance is to be paid on arrival in cash or in advance by bank transfer.

# 3. Deposit

Along with the entry and in order to have access to the second registration phase, participating countries will need to pay a deposit of 1700€ per team entered. The sum will be deducted from the total participation cost.

The deposit is non-refundable in the event of non-participation. Waivers to the payment of the deposit (LOC agreement), for whatever reasons, are to be discussed with the Local Organising Committee and to be agreed by the deposit payment deadlines.

All deposits for the first registered team per category are to be paid by December 31, 2019. All deposits for the extra teams are to be paid by January 31, 2020.
